## SUMMER JETTING OF SEWER LINES

The Village of Minong is planning a summer jetting project in certain areas of the Village. By keeping your lids down it will keep undesired sewer sludge from coming up out of the toilet. Be on the lookout for a big yellow truck this summer.



## Filling your Pool This Summer?

Please be advised that the Village of Minong will no longer allow residents to call in with their pool fill information.

We will be enforcing our ordinance under section 26-60 Bulk Water: All *bulk water* supplied to fill tank trucks or swimming pools from the *water* system through hydrants or other connections shall be metered. We will require residents to pay a \$40 refundable deposit to pick up a meter before the pool is filled and return the meter once finished so that we can get a more accurate water reading. Election Inspectors are the gatekeepers of democracy and are vital to efficient, open elections. Election inspectors are sometimes referred to as "poll workers". Election inspectors are responsible for election procedures in the polling location to which they are assigned. These procedures include, but are not limited to: helping to open the polls, registering voters, issuing ballots, providing assistance to voters, explaining the use of voting equipment, closing the polling location, and delivery of election returns.

#### Reminder—dog licenses due by april 1st, 2021

Pursuant to WI Stat/ 174-052, notice is hereby given to all Washburn County dog owners that you are required to license and vaccinate for rabies under the provisions of WI State. 95.21(2), any dog over 5 months of age. The license year is from Jan 1—Dec 31. Dogs not licensed within 30 days of ownership or after 5 months of age will be subject to a late fee of not less than \$5 per dog and will be subject to citation and forfeiture.

## **NOTICE TO ALL DOG OWNERS**

During 2020, the Village of Minong has received several complaints of dogs running lose in the Village of Minong. The Village would like to remind residents of the vital importance of keeping your dogs safe, in your own yard, or properly leashed while out walking. Below are some of the important ordinances we have in place if you neglect, mistreat, or do not properly supervise your dog. - 1. A license is required to keep a dog in the Village of Minong.
- 2. A dog or dogs must have a current rabies certificate in order to get a dog license.
- 3. A Multiple Dog License is required for three or more dogs and it must be approved by local law enforcement and the Village Board.
- 4. It is unlawful in the Village to keep a dog that habitually pursues vehicles, or people upon any public street, alley or highway in the Village.
- 5. No person shall harbor or permit to remain on their premises any animal that is habitually inclined toward attacking persons or other animals, destroying property or barking excessively, or making excessive noises.
- 6. No person having ownership of a dog shall allow the same to run at large in the Village. The owner shall keep his animal tied or enclosed in a proper enclosure so as not to allow said animal to interfere with the passing public or neighbors. Your animal, if found running at large can be seized and impounded by law enforcement.
- 7. Dog bites must be reported immediately to local law enforcement. The dog must be confined for not less than 10 days or for such period of time as the police department shall direct. The owner must surrender the dog to a humane officer upon demand for examination.
- 8. Owners of dogs will not allow their dogs to deposit feces on any street, alley or other public property unless such matter is immediately removed therefrom by said owner or person in charge.
- 9. It is unlawful for any person owning or possessing a dog to permit such animal to go upon any parkway or private lands, or private premises without the permission of the owner of such premises and break, bruise, tear up, crush, or injure any lawn, flower bed, plant, shrub, tree or garden in any manner, or to defecate thereon.
- 10. It is unlawful for any person knowingly to keep or harbor any dog which habitually barks, howls, or yelps to the great discomfort of the peace and quiet of the neighborhood or in such manner as to materially disturb or annoy persons in the neighborhood. Such dogs are hereby declared a public nuisance. An animal owner will be issued a written warning first. For second an subsequent offenses, the animal owner shall be subject to issuance of a citation and or prosecution by the Village attorney.
- 11. Neglected or abandoned dogs are unlawful in the Village. Law enforcement may remove, shelter and care for an animal found to be cruelly exposed to the weather, starved or denied adequate water, neglected, abandoned or otherwise treated in a cruel manner and may deliver such animal to another person to be sheltered and given proper medical attention, if necessary at the owner's expense.
- 12. If the animal or dog is determined to be hopelessly injured or diseased, it shall be lawful for such officer to kill the animal or dog and the owner shall not recover damages for the killing of such animal unless they can prove such killing was unwarranted.
- 13. No family shall own, harbor or keep in its possession more than two dogs on any residential lot without prior approval of the village board. If more than one family resides on a residential lot, then only a total of two dogs shall be allowed on the residential lot unless the prior approval is obtained from the village board.

The Village adheres to State Law regarding animal health, animals generally, dogs generally and crimes against animals. Full Village Ordinance information can be found at www.library.municode.com/wi/minong/codes/. Chapter 6– Animals.
