Filling out your Application

An operator license is a privilege, not a right. This form must be filled out accurately and completely. **Any false answers or omissions may result in the denial of your application and unable to apply again for a six-month period from the date of denial.** If you are unsure about how to answer any questions, check with the Village Clerk for clarification. Complete all items and return this form to the office of the Village Clerk with the appropriate fee. Allow two (2) weeks for a regular operator's license and two (2) days for a provisional operator's license.

New Applicants: State Statute 125.17(6) requires completion of a Beverage Server Training Course to be brought in before the application is reviewed. A Provisional license may only be issued if the application is enrolled in a training course, or if a course has been completed. You must provide proof of enrollment or completion prior to issuance of a Provisional license or your application will not be accepted.
