

# RESOLUTION# CV19-20 DECLARING A PUBLIC HEALTH EMERGENCY IN RESPONSE TO THE COVID-19 CORONAVIRUS

**WHEREAS**, COVID-19, a novel strain of the coronavirus, was detected in December 2019, and has subsequently spread throughout numerous countries and the United States, including Wisconsin; and,

**WHEREAS**, International Organizations, the Federal, State, County and Local governments are all working together to contain COVID-19; and,

**WHEREAS**, citing the World Health Organization's declaration of a Public Health Emergency of International Concern, and the United States Department of Health and Human Services declaration of a Public Health Emergency, the State of Wisconsin, Governor Tony Evers, has declared a Public Health Emergency of Executive Order #72; and Emergency Order #5; (Documents attached), and,


**WHEREAS**, the Village of Minong Board, Clerk's Office, Police Department, Fire Department and EMS Department have been kept up to date by Federal, State, and local County health departments about the spread of this disease, and to prepare for the impacts it may have; and,


**WHEREAS**, in order to protect the health and well-being of residents and visitors, the Village of Minong must avail itself of all resources needed to respond to and contain the presence of COVID-19; and adopt the restrictions as described in the State of Wisconsin Public Health Emergency Order #72; and Emergency Order #5; and,


**NOW, THEREFORE, IT IS HEREBY PROCLAIMED**, by the Village Board of the Village of Minong, that a local public health emergency could spread to the Washburn County Wisconsin area including the Village of Minong; and,

**IT IS FURTHER PROCLAIMED AND ORDERED**, by the Village Board of the Village of Minong, that during the existence of a potential COVID-19 local emergency; the powers, functions and duties of the board and board appointed emergency manager coordinator so named; Laury Lee, shall be those prescribed by State Law, and by any applicable ordinances and resolutions of the Village of Minong to coordinate with the necessary Federal, State, County and Local emergency departments to combat the spread of COVID-19.

**IT IS FURTHER PROCLAIMED AND ORDERED**, on March 19<sup>th</sup>, 2020 at: 9:00 (a.m./p.m.) by the Village Board of the Village of Minong, on behalf of the residents of the Village of Minong, will do whatever is necessary and expedient to protect the health and well-being of the residents of the Village of Minong.
